- Nomination papers must be delivered to the Returning Officer, Wallfields, Pegs Lane, Hertford, SG13 8EQ on any day from the date of this notice but no later than **4pm on Wednesday 3rd April 2019**.
- If any election is contested the poll will take place on **Thursday 2nd May 2019**.
- Applications to register to vote must reach the Electoral Registration Officer **by 12 midnight on Friday 12th April 2019**. Applications can be made online: <https://www.gov.uk/register-to-vote>.
- Applications, amendments or cancellations of postal votes and amendments or cancellations of proxy votes must reach the Electoral Registration Officer at Wallfields, Pegs Lane, Hertford, SG13 8EQ by **5pm on Monday 15th April 2019**.
- New applications to vote by proxy at this election must reach the Electoral Registration Officer at Wallfields, Pegs Lane, Hertford, SG13 8EQ by **5pm on Wednesday 24th April 2019**.
- Applications to vote by emergency proxy at this election on grounds of physical incapacity or for work/service reasons must reach the Electoral Registration Officer at Wallfields, Pegs Lane, Hertford, SG13 8EQ by **5pm on Thursday 2nd May 2019**. The physical incapacity must have occurred **after 5pm on Wednesday 24th April 2019**. To apply on the grounds of work/service, the person must have become aware that they cannot go to the polling station in person **after 5pm on Wednesday 24th April 2019**.
