with 8 responders, one new in training.

Calls for the period of February to the time of this report are 14 and counting. We have had a mixture of jobs ranging from diabetic emergency's chest pain and cardiac arrests; all time critical life threatening. Not too many covid related jobs coming in now. Our joint agency training re commences from next month at the fire stations and we soon to offer CPR and AED awareness training to the police cadets and police.

We look forward to re start our face to face training in the local schools in the coming months.

The Parish Council agreed that it would wait to see what impact the latest circulation of information has to reduce the problem before it takes more restrictive action. However, it will continuously review the situation and should it persist, action will be taken.
